

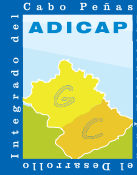
Two local councils in Asturias, **Carreño and Gozón**, are involved in the 'Sculpture and Atlantic Arc Landscape' Transnational Cooperation Project through the **ADICAP** Rural Development Group (**Adicap is the Cabo Peñas Development Association**). This Association is managing a Leader Plus European programme that areas in England (Northern Marches), Portugal (Aderes) and the 'Los Alcornocales de Andalucía' Rural Development Group are also participating in.

The project was launched to boost and stimulate the value of the participating areas' natural assets and cultural heritage, and focuses on contemporary sculpture in nature and in traditional rural settings within the Atlantic Arc to achieve this goal.

The project's aims are to conserve and to popularise natural assets and cultural heritage by establishing local art centres related to their physical environment and location, and to promote a common, shared image that will serve as a nexus and identification mark for all the natural settings within the Atlantic Arc. Other aims are to encourage exchanges between local and regional artists by having artists' meetings and events that share the themes of sculpture and the natural environment.

The project plans to run the following activities: creating and launching a European Network of Small Museums (www.epart.org), setting up a web page containing project-related information, interchanging sculpture exhibitions amongst partners, organising an itinerant contemporary open-air sculpture exhibition for the participating areas, and organising the 'Europe's Land's Ends' international sculpture competition.

The Asturias Savings Bank Cajastur, Gijón Port Authority, Arcelor steelmakers, Tudela Veguín cements and organisations such as the Universidad de Beira Interior, the Museo Antón in Candás and the Luanco Maritime Museum are all working on the project.
